Subject:-E – Tender for Comprehensive Annual Maintenance for High End Blade Servers and their related components.

DGFT invites e-Tenders under two-bid e-procurement system (Technical & Financial) from reputed and authorised firms through CPP Portal website (<https://eprocure.gov.in/eprocure/>) for awarding Annual Maintenance Contract for its High-End Blade Servers and their related components. The bidding firms must meet following criteria:

- The bidding organization should have annual turnover of not less than Rs. Five Crore (Rs 5 crore) in each of the last three financial years 2013-14, 2014-15 and 2015-16.
- The bidding organization **should have at least 5 years of experience** in successfully executing similar maintenance contracts in government organizations / Public Sector Organisations or reputed private sector organization.
- The bidding organization should have total manpower strength of atleast **fifty (50)** people including atleast **four (4) IBM certified technical staff**.

Scope of Work: The tender is for the comprehensive annual maintenance of all high end blade servers and their related components mentioned at Annexure A of the tender.

Terms and Conditions: The terms and conditions for annual maintenance for High End Blade Servers and their related components are given in the tender document.

Submissions: The bidder should submit application as per format given in Annexure B. The technical bid should be submitted in the format prescribed in Annexure C and the financial bid should be submitted as per the format prescribed in Annexure E. The technical bid shall be evaluated based on fulfilment of all prescribed norms and the qualitative and quantitative assessment of the experience etc. and only those found to be technically qualified and meeting the minimum standard laid down by the evaluation committee shall be declared to be technically qualified. The rates quoted in the financial bid document should be inclusive of all charges except taxes. No correction either in the technical bid or financial bid is permitted. Incomplete or ambiguous bids without documentary proof will not be considered. The tender documents can be downloaded from the website <https://eprocure.gov.in/eprocure/>.
