

As per the O.M.No.14014/19/2002 - Estt(D), dated the 5th May,2003, the maximum time a person's name can be kept under consideration for offering Compassionate Appointment will be three years, subject to the condition that the prescribed Committee has reviewed and certified the penurious condition of the applicant at the end of the first and the second year. After three years, if compassionate appointment is not possible to be offered to the Applicant, his case will be finally closed, and will not be considered again.

Note-2:

The appointment of the above candidates would be considered as and when vacancies arise under the 5% quota out of the Direct recruitment vacancies in the Group 'C' posts including MTS, in DGFT.
